The organization shall be known as Tri County Trap Club. A non-profit organization with power to make its own laws and regulations. Tri County Trap Club incorporated as a Domestic Nonprofit on 1/25/2010.

Section 1. Safety

- (a) It is the shoot officials and the shooter's responsibility to conduct the shoot in a safe manner and to advise any contestant of unsafe gun handling.
- (b) All guns must be kept open, unless in the gun rack, and unloaded at all times, except when on the firing line. Violators subject themselves to immediate disqualification, without recourse, with dismissal from the grounds. A second violation should be brought to the attention of the Board of Directors for review.
- (c) A contestant shall load their gun only when at the firing line and facing the traps. In singles and in handicap shooting, they may place only one shell in the gun at a time. In doubles they may place only two shells in the gun at a time. And they must empty the chamber before moving from one position to the next.
- (d) In case of misfire, the contestant shall keep their gun pointing downrange and open the gun with caution.
- (e) All guns used by contestants must be equipped and so used as not to eject empty shells in a manner to substantially disturb or interfere with other contestants.
- (f) The gun must be empty when the shooter is moving from post to post.
- (g) In handicap shooting, there shall be no more than two yards difference between adjacent shooters in the squad. The current ATA mandates and recommendations as amended from time to time will influence the club's squadding policy (See 5.07 - Squadding – Squads of less than 5).
- (h) The shooter on post five shall walk behind the other shooters when rotating to post one.
- (i) The practice of tracing targets behind a shooting squad is unsafe and disconcerting to the shooter and is not permitted.
- (j) As a safety precaution, no test shots are permitted.
- (k) Consumption of alcoholic beverages is not permitted during any TCTC shooting event.
- (I) Eye and ear protection must be worn.

Section 2. New Shooter Information

Section 2.01 Guests

- (a) A visiting shooter may shoot as a guest of the club at a reduced Guest Rate. The visiting shooter may shoot at the Guest Rate only twice during the TCTC shoot year.
- (b) After shooting twice at the Guest Rate visiting shooters shall pay the full member rate at subsequent shoots.
- (c) Shooters shooting as a Guest are ineligible for awards, unless otherwise specified.

Section 2.02 Annual Membership and Dues

- (a) Family membership: Family membership includes all family members for an annual fee of \$50.00. From April through September the annual fee will be reduced to \$25.00.
- (b) Individual membership: Individual members will be charged a fee of \$35.00 annually. From April through September the annual fee will be reduced to \$20.00.
- (c) A member receiving a Grand Champion award will be exempt from membership renewal fees for the next shooting year.
- (d) The club may run membership specials such as join in August and receive thirteen months membership.

Section 2.03 New Membership Initiation Fee.

- (a) New members will be charged an initiation fee of \$30.00 in addition to the annual membership fee.
- (b) New members are subject to review by the Board of Directors.

Section 2.04 Inactive Members

- (a) Any member whose dues remain unpaid 60 days after October 1st will be declared an "inactive member", and may be removed from the mailing list.
- (a) Inactive members, whose membership has lapsed 12 months or more, will be charged the standard initiation fee as well as the annual membership fee when reactivating their membership, unless waived by the Board of Directors.
- (b) Re-qualification for awards and jackpots is also required if the shooter's membership has lapsed 12 months or more.

Section 2.05 Membership and Target year.

The membership and target year shall run from October 1st through September 30th.

Section 2.06 Members Rights.

A member who believes he or she has been damaged by any official ruling may file a complaint with the Board of Directors in writing within 30 days of the alleged grievance. If the Board determines that restorative action is appropriate it will cause that action to occur. No such action will negatively affect any other member who may have benefited from the original official ruling.

Section 3. Classification and Handicap Yardage Assignments.

Section 3.01 Classification of New Members Who Are A Member of Another Trap Shooting Association.

A new member who has previously been a member of another trap shooting association must notify the club handicapper and initially shoot at their last classification and/or yardage, if it is greater than the TCTC new member minimum requirements until they have undergone a three score review.

Section 3.02 Singles and Doubles Classification of New Shooters who are not members of another Trap Shooting Association.

- (a) New male shooters will be assigned to "B" Class, until known ability has been established by the results of 3 shoots.
- (b) New Lady and Junior shooters will be assigned to "C" Class until known ability has been established by the results of 3 shoots.
- (c) The handicapper may modify these classifications as circumstances warrant.

Section 3.03 Handicap Yardage Assignment for New Members who are not members of another Trap Shooting Association.

- (a) The Handicapper shall have discretion to classify new members according to the following guidelines
 - (1) New or beginner shooters may be assigned to the 20 yard line.
 - (2) All other shooters will be assigned to the 24 yard line.

Section 3.04 Sub Classification

- (a) Shooters eligible for a sub classification can participate in only one sub-class at a time. The order of precedence is:
 - (1) Guest shooter: Any non-member participating without classification or eligibility for awards.
 - (2) Junior Shooter: Any shooter 12 years of age, but not yet the age of 18.
 - (3) Lady Shooter: All females shooters 18 years of age or older.
 - (4) Veteran Shooter: 65 to 70 years of age.
 - (5) Senior Veteran: 70 plus.

(b) It is the responsibility of a Lady, Jr., Vet or Sr. Vet to note their eligibility for subclassification on their shoot ticket in order to qualify for any sub-class awards.

Section 3.05 Responsibility for Proper Classification

It is the responsibility of each shooter to shoot in their correct class and/or yardage group. Any shooter competing in the wrong class or yardage must, for that event or events, forfeit all prizes, trophies, and buckle points otherwise earned in that event.

Section 3.06 Classification / Yardage Assignment Review

- (a) Monthly Advances.
 - (1) Singles and Doubles: The Handicapper will increase, by one class, the classification of any member who:
 - Shoots or ties the high score in his or her class. And
 - ii) Shoots a score equal to or greater than the established points score for the class.

The next review will take place 3 months from the Win or Tie Date.

- (2) Handicap: The Handicapper will increase, by one yard, the assigned yardage of any member who shoots or ties the high score in his or her yardage group. The next review will take place 6 months from the Win or Tie date.
- (b) Singles & Doubles Three Score Review for Average Reductions & Advances.

After the initial 3 month period (Oct-Dec), if the shooter has not won or tied in those first 3 months, the handicapper will review on a 3 score rotating basis (dropping the oldest score and adding the newest score). Shooters will not be eligible for a review if they have won or tied the winning class score during their prior three events.

(1) REDUCTIONS: The Club Handicapper will reduce, by one class, the Singles or Doubles Classification of any member whose three score average, since the beginning of the shoot year is below the previous year's club average for that class. .

- (2) OVER AVERAGE ADVANCE:
 - i) There are 2 conditions that MUST occur to receive an Over-Average Advance:
 - a. The Shooter's actual average must exceed their class maximum as indicated by the table in section 4.02 (b) (6)
 - b. Two of the Shooter's last three scores must be equal to or greater than the over-average score of the next highest class. If both of these conditions are present then the shooter will advance one class.
- (c) Six Score Handicap Reduction Review
 - (1) There will be two handicap reduction reviews per shoot year (April & September).
 - (2) The Club Handicapper will reduce, by one yard, the handicap yardage assignment of any member whose six score average, is under that period's established reduction target average. For example the reduction target average in the second half of 2014 is 45.
 - (3) A member may refuse to accept a reduction in class or yardage but if they do they will remain at their pre-reduction class or yardage for the balance of the shoot year except if they win or tie.

None of the above reviews will result in an increase or reduction in classification or handicap yardage assignment of more than 1 class or 1 yard.

- (d) Year End Review.
 - (1) Singles and Doubles. The club Handicapper will review each member's single and doubles classifications before the start of the new target year. The Handicapper will determine a starting class based on a yearlong average, along with quarterly scores, separately for singles and doubles. The Handicapper will use the table in section 4.02, (b), (6) to determine a member's class for the beginning of the next shoot year. The maximum change is two classes.
 - (2) **Handicap**. After the September shoot the club Handicapper will conduct any required 6 shoot reviews plus move winners up. The members ending yardage will also be the beginning yardage for the following year.
- (e) Effect on class or yardage assignments from other organizations.

After the initial class and yardage assignments a member's classification or yardage will no longer depend on their class or yardage in any other organization.

Section 3.07 Handicapping Renewing Members

Any shooter re-applying for TCTC membership, who was previously assigned to a classification or handicap yardage, shall resume shooting at that classification and yardage unless the shooters ATA classification or yardage, if applicable, is greater than the previous assignment.

Section 4. Awards and Prizes

Tri County Trap Club offers a unique "Multiple Awards System" of Monthly Awards, Annual Champion and Class Champion Awards and Special Achievement Awards. A shooter may win more than one 1st place award in any monthly shoot, unless otherwise specified.

Section 4.01 Monthly Awards

- (a) 16-Yard Singles.
 - (1) Awards are provided for the 1st place score in each class.
 - (2) Awards are also provided for High Lady, High Vet, High Sr. Vet and High Jr. provided that the member did not win their class in singles. Winning an over average point does not exclude a member from the sub-class win. Only Shooters who declare their eligibility at the time of entering the event are eligible for subclass awards.
- (b) Handicap and Doubles.
 - Awards are provided for the 1st place score in each yardage group and for the 1st place score in each doubles class. There are no sub-class awards.
- (c) Champion and HOA
 - (1) Awards are provided for the overall HOA Champion(s) and all HOA class winner(s) or ties.
- (d) Other awards
 - From time to time the board of directors may add other awards. These will be separate from those outlined above. The rules governing these separate awards will be determined at the discretion of the board. Examples of these awards have been the monthly buckle program and Hunter awards.

Section 4.02 Annual Champion and Class Champion Buckle Awards.

The annual champion buckle program provides for a minimum of 32 awards for shooting achievements based on the members average and participation throughout the shoot year. A member receiving a Grand Champion buckle will become ineligible for any lesser award. A member receiving a High Over all Class Champion buckle, or a High Singles, High Handicap, or High Doubles buckle, will become ineligible for the lesser singles, doubles or handicap championship awards, but is eligible to receive more than one buckle of the buckles itemized here. In the case of tie scores, duplicate buckles will be issued.

- (a) The awards are as follows:
 - (1) (High over All) Grand Champion (min. of 1 Buckle)
 - (2) (High over All) AAA-AA-A-B-C-D Champions (min. of 6 Buckles)
 - (3) High Single, Handicap and Doubles Champions (min. of 3 Buckles)
 - (4) 100 Singles AAA-AA-A-B-C-D Class Champions (min. of 6 Buckles)
 - (5) Handicap Yardage Group Champions (min. of 5 Buckles)
 - (6) Doubles Class AAA-AA-A-B-C-D Champions (min. of 6 Buckles)
 - (7) Lady, Veteran, Senior Veteran and Jr. Champions (min. of 4 Buckles)
 - (8) Past President Award (1 Buckle)
- (b) Qualification for Annual Championship Buckle Awards.
 - (1) The member must participate in at least 9 monthly shoots to qualify.
 - (2) Qualifiers averages are calculated using the member's best 9 scores for the target year in each of Singles, Handicap and Doubles.
 - (3) Your HOA Class is the same as your "best 9" Singles Class. HOA is calculated by adding your best 9 singles average plus your best 9 handicap average plus your best 9 doubles averages.
 - (4) Your award Handicap group is your beginning of the year yardage.
 - (5) Awards are calculated in the exact order listed in 4.02(a).
 - (6) Classes for Singles and Doubles Annual Championship Buckles are not necessarily based on the class a member shoots in during the year, but rather based on where his best of nine average falls on the following table.

Section 4.03 Annual Special Achievement Award(s).

(a) 12-Point Buckle Award Program.

This program awards points to shooters who shoot scores equal to or higher than the previous year's average winning scores. Qualifications Are:

- (1) The member must be in good standing to be eligible.
- (2) The member must earn a minimum of 12 buckle points in the target year. Points cannot be carried over from one target year to the next.
- (3) The winning score by class or yardage in Singles 100, Handicap and Doubles earn 1 point.
- (4) The HOA Champion and the HOA class winners earn 1 point.
- (5) The High Lady, High Vet, High Sr. Vet and High Jr. winners each earn a point for their high score in the Singles sub-class except when they have already earned an over average point in the Singles 100 event.
- (6) A member shooting a score equal to or higher than the previous target year's 12 month average winning score in the member's Class or Yardage Group will receive a point unless the member earned a point for high score in that Class or Yardage Group. Winning a point by this method does not necessarily mean the shooter will receive advancement in class.
- (7) It is possible for more than one shooter per Class to earn a point.
- (8) It is not possible for any shooter to earn more than 1 point per event or more than 4 points per shoot.
- (9) A 12-Point Buckle will be awarded to qualifying members the first time they qualify. Members who qualify again in subsequent years will receive a 3 mm (10 point) diamond enhancement installed in their original buckle with the year earned engraved next to the diamond. The diamond and date will be awarded each subsequent time the member qualifies.

- (b) The Champion of Champions Shoot.
 - (1) The Champion of Champions competition will occur concurrently with the typical monthly club shoot in July.
 - (2) The Champion of Champions trophy will be awarded to the qualifying member shooting the High Over-All score at the above mentioned Club shoot. The Champion of Champions trophy could be a buckle, leather products or other awards as determined by the club's current board.

(c) The Qualification for the Champion of Champions Award:

There are three ways to qualify. In all three ways the member must have participated in a minimum on nine shoots from October of the prior target year through June of the current target year (9 out of 21 shoots).

- (1) Nine shoots (see above) plus the member must have earned a minimum of 12 point buckle in any prior target year.
- (2) Nine shoots (see above) plus the member must have earned 12 points from October of the current target year through June of the current target year.
- (3) Nine shoots (see above) plus member must have won at least one Singles Event, one Handicap Event and one Doubles Event from October of the prior target year through June of the current target year (9 out of 21 shoots).
- (d) Shoot-Off for Tied Scores for the Champion of Champions HOA Award consisting of 40 targets as follows.
 - (1) Ten single targets.
 - (2) Ten handicap targets from their designated yardage.
 - (3) Ten pair of double targets
 - (4) Shooters will continue with additional 40 target sets until the tie is broken. Shoot-off sub-events must be completed.
 - (5) If the shoot off is a carryover to the next month's shooting event then the 40 target sets will be determined by using the first two targets on each post of the first field in both singles and handicap. Doubles will use the first two pair on each post. This format will continue to repeat until the tie

is broken if possible. This array of targets from each post by all competitors will best emulate an actual shoot off.

- (e) The awards are as follows:
 - (1) Champion of Champions Award (1).
 - (2) Awards determined by president for HOA-AAA, HOA-AA, HOA-A, HOA-B, HOA-C, HOA-D, HOA-Vet, HOA-Senior Vet, HOA-Lady, and HOA-Junior

Section 4.04 Handicap Jackpot

- (a) An optional rolling Jackpot in each handicap yardage group is available to members and can be entered at the time of event entry.
- (b) New members must participate in a minimum of six Tri County shoots before they become qualified to enter the jackpot. These six shoots do not need to be consecutive, nor do they need to be in the same calendar year.
- (c) Any member who has missed six consecutive shoots, become disqualified and must re-qualify to again become eligible to enter the jackpot.
- (d) Any qualified member entering the jackpot, who shoots a perfect 50 in the handicap event, shall win the total amount in the yardage group jackpot. Any entry that shoots a score of 49 will win half the yardage group jackpot, if not paid to someone shooting a 50.
- (e) Shooters with tie scores will divide their yardage group jackpot amount equally.
- (f) It is the responsibility of members who enter a jackpot to be knowledgeable of and abide by the jackpot rules. Any ineligible member who pays a jackpot fee will have the fee refunded.
- (g) Jackpot fees accumulate and totals grow until won by a qualified entrant. Current jackpot amounts are published in the newsletter and are available at each monthly shoot.

Section 5. Tri County Trap Club Tournaments.

Section 5.01 Guns and Ammunition.

- (a) The largest gauge used in TCTC competitions is 12 gauge. Guns of smaller gauges are permissible, but no consideration shall be given to their use in any shooting event.
- (b) Shot charges shall be no larger than 1 1/8 oz. of number 7.5 and be made from lead. Tracers, copper, and nickel-coated shot are not allowed.
- (c) Ammunition velocity must conform to current ATA rules. Black powder is not permissible.

Section 5.02 Responsibilities of a Tri County Trap Club Member

- (a) A contestant must be prepared to compete when called by the shoot director.
- (b) Shooters not responding when called may be subject to re-squadding, and if not present to shoot after re-squadding may forfeit all event fees.
- (c) A contestant must in no manner interfere with the other shooters on the squad.
- (d) It is the duty of the contestant to see that his or her score, as determined by the referee, is correctly recorded. In case of error, it shall be the duty of the contestant to have the error corrected before firing a shot on their next post or before they leave the trap if the target was within the last five targets of that sub-event.

Section 5.03 16 Yard Singles

(a) A 16 yard six class system will be used: Classes AAA, AA, A, B, C and D. This event must be shot five shots at each post from 16 yards with each shooter in order shooting at one target until all have shot five times, and rotating in a clockwise manner to the next post.

Section 5.04 Handicap Targets.

- (a) There will be five yardage groups assigned: 20, 21, 22-24, 25-26 and 27. This event must be shot five shots at each post, with each shooter shooting at one target at a time until all have shot at five targets, and then rotating in a clockwise manner to the next post.
- (b) A contestant must stand on the highest whole yardage assigned to him or her. For example, if a shooter is assigned 20.5 yards, then the shooter must stand on

the 20-yard line. A shooter may not stand on a higher yardage than they are assigned.

Section 5.05 Doubles

(a) This event must be shot from 16 yards with each shooter in order shooting at two targets thrown simultaneously from the trap house until all have shot at 5 pair of targets, and then rotating in a clockwise manner to the next station.

Section 5.06 Squadding – Squads of 5.

(a) In all Club events contestants shall shoot in squads of five except when there are less than five contestants available in an event.

Section 5.07 Squadding – Squads of less than 5.

- (a) When the yardage difference in handicap make it unsafe.
 Guidance:
 Squads with 18,19 or 20 yard shooters, no more than 1 yard between shooters and a max difference of 2 yards in the squad.
 Squads with 21 to 27 yard shooters, no more than 2 yards between shooters and a max difference of 3 yards in the squad.
 (b) When these are with drawals from the squad.
- (b) When there are withdrawals from the squad after the competition has begun and the squad is scheduled.
- (c) When, in the opinion of the Club officials, the harmony of the shoot may be enhanced by squadding less than five.

Section 5.08 Squadding – More than 5.

(a) Squads of more than five shooters are NOT allowed.

Section 5.09 Squadding – Practice Shooters.

(a) The Squadding of practice shooters with those shooting club events shall NOT be allowed.

Section 5.10 Squad Leader – The Shooter in Position One is the Squad Leader and Should.

- (a) Ascertain that all members of the squad are ready before commencing the event.
- (b) Call for one (only one) target or pair before starting their squad to shoot the sub-event.
- (c) Verify the scores with the squad and scorer, and initial the score sheet at the end of each sub-event.
- (d) Return the squad sheet to the handicapper and verify the recording of all scores after shooting the event.

Section 5.11 Shoot Interruptions.

- (a) If during an event, a contestant is thrown an illegal or broken target, the contestant shall have the right to see one legal target or pair before resuming shooting.
- (b) If there is a delay due to trap or gun trouble, the contestant in turn may ask to see a target.
- (c) A change of fields for any reason is not permitted without the permission of the Shoot Director.

Section 5.12 Official Scoring of Broken or Dead Targets.

(a) A broken or dead target is one that has a visible broken piece from it, or one that is completely reduced to smoke. If no perceptible piece is seen, it is not a broken target. Dust off a target is NOT a broken target.

Section 5.13 Lost Targets – When The Scorer shall call "LOST"

- (a) When the contestant shoots and fails to break the target, either missing completely or when only dust is seen.
- (b) When the whole target appears promptly at command of the contestant and is within the legal limits and the contestant does not voluntarily shoot.
- (c) When an illegal target, or a freak target, is shot at and missed. Contestants may refuse illegal targets but if they shoot the results must be recorded.
- (d) If a contestant has more than two failures to fire in any sub-event any additional failures to fire will be recorded as a lost target.

- (e) When a contestant voluntarily withdraws from or is disqualified, and takes no further part in the event after having shot one or more targets, and thereby, has not shot the total number of targets for that event, the referee shall declare all targets not shot at as lost and scored accordingly.
- (f) When the score sheet comes in to the Recorder or Handicapper with one or more targets not scored at all, they shall be scored as lost.
- (g) If a contestant uses a shell after it has misfired, they shall abide by the result obtained through the use of that shell.
- (h) A contestant whose firearm breaks during the competition will have five minutes to repair or replace the firearm and continue. If unable to do so, they must re-squad if possible, otherwise the remaining targets of the sub-event are to be scored as lost.
- (i) Current ATA scoring rules as amended from time to time will take precedent.

Section 5.14 Tie Scores and Shoot-Off Rules.

- (a) Ties will be determined by Long Run.
- (b) Long Run will be determined by the longest string of broken targets anywhere within the score.
- (c) If there is a long run tie, the winner will be determined by the 2nd and 3rd long run respectively, of that event.
- (d) Shoot management will decide the nature of awards for unresolvable ties.

Section 5.15 Shoot Cancellation

(a) A consensus among the participating shooters will determine the modification, postponement, or cancellation of an event due to inclement weather, darkness or other causes.
